INCLUSION OF BLANKET PROVISION CONFIRMING THAT NO FORMED COMMITTEE WILL REMOVE THE BOARD'S POWER TO ACT ON CERTAIN MATTERS, THAT BOARD MEMBERS MAY SERVE AS ALTERNATES ON COMMITTEES IF THERE ARE VACANCIES AND THAT EACH COMMITTEE SHALL MAKE ITS OWN SPECIFIC RULES AND REPORT BACK TO THE BOARD ON ACTIVITIES, AND BLANKET PROVISION CLARIFYING AND APPROVING ANY PRIOR AND/OR FUTURE ACTIONS TAKEN BY THE BOARD THAT MAY NOT HAVE BEEN IN COMPLIANCE WITH THE BYLAWS THAT WERE FORMALLY APPROVED AT THE TIME.

FORM 990, PART VI, SECTION A, LINE 8B:  
THE ORGANIZATION DOES NOT HAVE ANY COMMITTEES WITH AUTHORITY TO ACT ON BEHALF OF THE GOVERNING BODY.

FORM 990, PART VI, SECTION B, LINE 11B:  
BOARD MEMBERS REVIEW AND APPROVE THE 990 BEFORE THE RETURN IS FILED WITH THE IRS.

FORM 990, PART VI, SECTION B, LINE 12C:  
THE POLICY COVERS DIRECTORS, OFFICERS, AND EMPLOYEES OF MAYDM. DETERMINATIONS ARE MADE AT THE MANAGEMENT LEVEL AS TO WHETHER A CONFLICT OF INTEREST HAS ARISEN. A PERSON MUST DISCLOSE THEIR CONFLICT OF INTEREST AND REPORT TO CHAIR OF A MEETING IF THEY PLAN NOT TO ATTEND BECAUSE THEIR CONFLICT OF INTEREST AND SAID PERSON CANNOT ATTEND THE MEETING DUE TO THE CONFLICT. SAID PERSON WILL ALSO NOT BE COUNTED WHEN THE COUNT FOR QUORUM IS CONDUCTED, AND THEY MUST REFRAIN FROM ANY ACTIONS THAT MAY IMPACT MAYDM.
